


ARTICLE 1: To see if the Village District will vote to elect by unofficial ballot the following:

ARTICLE 2: To see if the Village District will raise and appropriate the sum of \$62,614 for general municipal operations. The sum of \$23,000 from unassigned fund balance will be used to offset this appropriation. This article does not include appropriations contained in special or individual articles addressed separately. (Majority vote required)




